1. I am Calum Alexander McMillan (known as Calum McMillan) and I reside at 6 Ettrickdale Road, Port Bannatyne Rothesay PA20 0QZ. I am 59 years of age.
2. I was educated at Rothesay Academy. I come from a local island family with generations of mariners and boat builders. I own and operate the business of Argyll Workboats Ltd , formerly Argyll Workboats , and own the commercial vessel Seahorse II which has Rothesay Harbour as its home port.
3. I am not related, in any way, to Councillor Michael Breslin, and have no family or social connections to Councillor Michael Breslin.
Nor do I have any business relationship or association linked to Councillor Michael Breslin in any way either now or in the past.
4. My first contact with Councillor Michael Breslin was in 2013 in his sole capacity as an Elected Member for Argyll & Bute Council within Rothesay Harbour Board.
5. All contact between Councillor Breslin and my business Argyll Workboats Ltd has been directly related to issues and problems that I have experienced at Rothesay Harbour and in his capacity as a Rothesay Harbour Board Member and an Argyll & Bute Councillor.
6. Councillor Michael Breslin has no personal interest in either myself or my business Argyll Workboats Ltd .
